Reason for Dues Increase

• Significant reduction in external funding, leading to reliance on stable, predictable member dues.

- Operational budget reduced by 46% since FY22/23 and the conclusion of AmeriCorps.
- Shift in funding model away from voluntary contributions to mandatory dues to ensure financial stability.

New Proposed Dues Structure (FY 2026-28)

- FY 2025-26: Base rate \$6,000 + \$2.60 per birth.= \$7,206.40
- FY 2026-27: Base rate increases to \$8,000 + per-birth cost. \$9,206.40
- FY 2027-28: Base rate increases to \$10,000 + per-birth cost. \$11,206.40
- Maximum dues capped at \$95,000 per member county.
- Flexible payment arrangements available for counties facing financial constraints.

Benefits Funded by Membership Dues

- Advocacy: Represents local interests in legislative advocacy, securing potential state funding.
- Communications Support: Offers customized advocacy tools, weekly newsletters, and strategic messaging resources.

• Peer Learning and Networking: Facilitates collaborative events and professional development opportunities.

• Intermediary Services: Efficient grantmaking processes and consultation on program and policy implementation.

Recent Key Activities (2022-2024)

- Strategic sustainability planning addressing declining tobacco tax revenue.
- Legislative advocacy (AB 2982, SB 326), securing policy recognition for early childhood priorities.
- Secured commitment for a \$2 million stabilization fund from First 5 California.
- Enhanced collaboration between Medi-Cal Managed Care Plans and First 5 county commissions.
- Community and statewide engagement for sustainability and scale.

Greetings SPCFA Partners,

To support small-population counties in California with local budget commission planning, First 5 California (F5CA) is sharing the first fiscal year (2025-26) of the three-year funding (2025-28) aimed at augmenting annual tobacco tax revenues to local First 5 Commissions in counties with small populations and low birth rates. F5CA is pleased to share that the first-year annual harmless funding will assist the infrastructure of small counties for the first fiscal year 2025-2026, which replicates the prior 2020-2024 annualized funding. In the next weeks, F5CA will release the Request for Application, along with the remaining grant funding breakdown.

The Small Population County Funding Augmentation (SPCFA) aims to enhance the operational capacity of California's small population counties so that every child from ages 0 to 5 in the state, regardless of their place of birth, has access to a comprehensive range of programs and resources.

The funding purpose supports F5CA's Audacious Goal, which states that, within a generation, all children prenatal to age five will have safe, stable, nurturing relationships and environments necessary to achieve healthy development.

Eligibility:

The twenty-one (21) First 5 county commissions, in good standing, and whose annual average birth rate is less than 1,000, are eligible for the SPCFA grant. The list of the identified small population counties and their potential funding allocations for the first fiscal year, 2025–2026, is listed in the SPCFA Allocation by County table.

Eligible small population counties must have satisfied the following:

- Deliverables/requirements from prior and current F5CA grant awards. This includes but is not limited to submission
 of all required reports, grant-funded project(s), obligations, and deliverables from prior and current F5CA grant
 awards and contracts.
- Statutory reporting requirements according to Proposition 10 for the prior fiscal year, such as submission of the Annual Report, Annual Audit, and submission of a F5CA Certification for Compliance (see Section 6, C. for details).

The SPCFA Allocation by County table below displays the amount of funds granted to each county commission for the first fiscal year, 2025-2026, under the SPCFA Request for Application, which runs from July 1, 2025, to June 30, 2028. Funding amounts for subsequent fiscal years are subject to change over the term of the grant cycle.

SPCFA was created to correct the legislation which didn't take small counties into account in the tax allocation calculations.

Since 2014/2015 First 5 Tuolumne has had a decline of 10.4% revenue. Our revenue has been stabilized by funding from First 5 California but is now at risk of significant decline.

The RFA has been released and applications are due July 3, 2025.

The data used in calculations by First 5 California have been unclear and in year 3 have Tuolumne County receiving the smallest allocation out of the smallest 21 coiunties although our population is significantly smaller than many of these counties.
