Laura Sunday- She introduced that CNVC will be attending the next meeting for a presentation.

Sarah Garcia- We are currently undergoing our annual audit to ensure we are meeting our legislative requirements. In September, the last of the 3 leadership cohort convening will be in Palm Springs. It has been a very useful experience and will be a great way to connect First 5 Tuolumne to the greater First 5.

Commissioner Woodruff asked about the status of the small grants available. There were not any applicants in the first cycle. Sarah let the group know there is another cycle open until November. Sarah Collie asked that we advertise the opportunity more. It was requested that the application be resent to the group.

We received the MHSA grant for the Supporting Early Education and Development (SEED) program in the amount of \$20,000

Cathy Parker- the SEED coordinator has been hired, Beth Barnett. She was the Director of the Belleview State Preschool. There have been great opportunities for professional development for her to build a great foundation. Donna Meiss will be able to continue to work to assist with the transition for Beth. Beth's office will no longer be in with Erica since Erica has been able to expand the Smile Keepers program and has hired another employee. August is Immunization Awareness Month. The County has been working to

- improve the immunization numbers throughout the county. Public Health will be posting information on social media to increase public awareness.
- Sarah Collie: There has been a change in leadership at the Tuolumne Me Wuk Indian Health Center. Commissioner Collie is in two schools this year.
- Chris Mackenzie: She announced that she has stepped into the Executive Director roll at Infant Child Enrichment Services. Natalie is working to get her Marriage and Family Therapist license. She will be doing interventions with families through Raising Healthy Families. She currently has 16 families. This is a unique program because it is free. They are also looking to hire a family support specialist. Resource and Referral team has also hired a new person.
- Rebecca Espino: They are now partnering with ATCAA and Public Health to do home visiting through a new grant.
- Annie Hockett: Tuolumne Resiliency Coalition had Dr. Ross Greene and there was great feedback and many want him back. The coalition wants to do one training event per year.
 - Laura Sunday commented about how much her staff really liked the content and they are excited to use the information in their work.
- Dee Keshner: Was a school psychologist and a LMFT and is interested in getting involved in First 5.
- Donna Fone: She is now the new MHSA coordinator and has extensive experience working in behavioral health both in the clinical setting and management setting.
- Laura Sunday: CNVC staff loved Ross Greene. They also saw Christian Moore who has a curriculum on resiliency. CNVC also has a goal of doing the puppet presentations in all preschools in the county.
