 Unite Tuolumne County (UTC)
 26 Month Contract (May 1, 2022-June 30, 2024)

GOAL	To identify and mitigate developmental delays in children & address social determinants of health risk factors to help Tuolumne County residents reach their optimal development and be prepared to succeed in school and in life.		
OUTCOME	To increase child/parent access to developmental & social/ determinants screenings utilizing tools such as Ages & Stages Questionnaire 3 (ASQ3} & Social Determinants of Health (SDOH). To provide resources & referrals to children/families to mitigate developmental delays and/or social determinant risk factors. To reduce barriers that prevent Tuolumne County residents from accessing available quality services for their optimal health and development.
