Item 3. Consideration to accept the application of Donna Fone to the First 5 Commission (attachment #3)

Details: We currently have two openings for Community Representative Commissioner Alternates. We have received one application from Donna Fone, which is included following the outlining of our Bylaws.

According to our Bylaws:

Article II. Members

Section 1. Number, Qualifications, Selection, Appointment and Term:

A. Regular Members:

The Commission shall consist of seven (7) members. Of these seven members, three shall consist of one (1) member of the Board of Supervisors, the Human Services Agency Director or his/her designee, and the County Health Officer or his/her designee. The Human Services Agency Director and the Health Officer may appoint a designee only if the designee is responsible for management of the following county functions: children's services, public health services, behavioral health services, social services, and tobacco and other substance abuse prevention and treatment services (as required by the California Health and Safety Code Sec. 130140). The remaining four (4) members, herein referenced as Community Representative Commissioners, shall be appointed by the Board of Supervisors and shall represent any of the following categories:

- 1. consumers of project services included in the County Strategic Plan;
- 2. educators specializing in early childhood development;
- 3. representatives of a local child care resource or referral agency or a local child care coordinating group;
- 4. representatives of a local organization for prevention or early intervention for families at risk;
- 5. representatives of community-based organizations that have the goal of promoting nurturing and early childhood development;
- 6. representatives of local school districts; and
- 7. representatives of local medical, pediatric or obstetric associations or societies. Commission members shall be appointed by the Board of Supervisors with staggered terms in accordance with § 8.40.070 of Tuolumne County Ordinance Code.

The Commission member who is a member of the Board of Supervisors shall be appointed annually by the Chair of the Board of Supervisors, and there shall be no limits on terms. The Human Services Director and the Health Officer shall be appointed initially by the Board of Supervisors, and they, or their designees, shall serve indefinitely, or until the Board of Supervisors chooses to appoint a replacement who meets the criteria set forth in the California Health and Safety Code Sec. 130140.

The four (4) additional Commission members appointed by the Board of Supervisors shall serve at the pleasure of the Board of Supervisors. The Board of Supervisors shall seek a recommendation from the Commission on applications for appointment to the Commission prior to the Board of Supervisors making an appointment of a Commission member. The term of office of these four members of the Commission shall be for three (3) years and until the appointment of their successor. There shall be no limit on terms.

B. Alternate Members:

The Board of Supervisors may appoint Alternate Commissioners, as follows:

- 1. The Board of Supervisors may appoint an alternate Commission member of the Board of Supervisors (with no term or term limits until replaced).
- 2. The Board of Supervisors may appoint up to two (2) alternates designated by the Human Services Agency Director and the County Health Officer that represent any of the following categories consistent with the Health and Safety Code § 130140: persons responsible for management of children's services, public health services, behavioral health services, social services and tobacco and other substance abuse prevention and treatment services (with no term or term limits until replaced).
- 3. The Board of Supervisors may appoint four (4) Community Representative Alternates that represent any of the following community representation categories, consistent with Health and Safety Code § 130140. Alternates can represent any one of these categories, regardless of the representation of current Commissioners and Alternates:
 - a) recipients of project services included in the Commission Strategic Plan;
 - b) educators specializing in early childhood development;
 - c) representatives of a local child care resource or referral agency or a local child care coordinating group;
 - d) representatives of a local organization for prevention or early intervention for families at risk;
 - e) representatives of a community–based organization that have the goal of promoting nurturing, and early childhood development;
 - f) representatives of local school districts; and
 - g) representatives of local health care, medical, pediatric, or obstetric services, associations or societies.

The term of office of these Community Representative members of the Commission and alternates shall be for three (3) years and until the appointment of their successor. Community Representative members or alternates may be reappointed for additional 3 year terms, and there shall be no limit to the number of 3-year terms served. In the event of vacancy or absence of one of the Commissioners representing the 3 legislated county positions (Board of Supervisor, Human Services Agency Director or designee, and Health Officer or designee) the designated Alternate for that Commissioner shall serve to meet quorum requirements and shall fill the vacancy or vote in place of the absent Commissioner.

In the event of vacancy or absence of one of the Community Representative Commissioners, any one of the Community Representative Alternates shall be eligible to serve in order to meet quorum requirements, to fill the vacancy or to vote in place of the absent Commissioner. The absent Commissioner shall designate which Community Representative Alternate shall serve in his or her absence. If this is not possible, the Commission Chair shall determine which Community Representative Alternate shall serve in place of the absent Commissioner.

All sections of these By-Laws that apply to Commissioners shall apply equally to Alternates.



Details: The California State Office of Oral Health has requested to use the First 5 Smile Keepers data for a project to review the program and see how it is working. This contract is between First 5 Tuolumne and the Office of Oral Health to pay a contractor to remove all personal identifiable data so it may be used.

Scope of Services

Remove all personally identifiable data from the Smile Keepers Excel database for children up to age Kindergarten in Tuolumne County, for the years FY 07-08 to FY 2018-19. (14 years). Provide the following elements to the State of CA or their designee electronically in Excel format:

- 1. <u>Child Identifier</u>: Each child will be identified by a simple numeral, #1, 2,3 etc. These will be unique to each child and will serve as an individual identifier year to year.
