As part of our ongoing commitment to providing you with the highest level of service and value, we continually evaluate the costs associated with delivering our programs, events, policy, advocacy, and resources.

After a thorough financial analysis, the First 5 Association staff and Board of Directors are recommending an increase in membership dues. This adjustment will ensure we can continue to deliver member benefits, expand initiatives, and maintain the quality of services you rely on.

Effective Date: July 1, 2025

New Membership Dues: \$11,205.43 (previously \$4,000, including your voluntary policy fund contribution)

New Membership Dues Formula: \$10,000 + \$2.60 per live birth (based on 2020 birth dates)

We understand this dues increase will have an impact, and we remain dedicated to maximizing the value of your membership. This increase will directly support our new Strategic Framework, ensure persistent, high quality advocacy and engagements, and drive specific goals including:

- Early Childhood and Family Policy advancements focused on economically secure families, comprehensive health and development, and early childhood care and education.
